**Agreement:**

This agreement, made on this date \_\_\_ / \_\_\_ of \_\_\_\_\_ regarding the sale of said dog/puppy: By and between Pamela Davis herein after referred to as Breeder and Buyer Owner herein after referred to as Buyer.

The Breeder certifies that the dog is eligible for registration under the Regulations of the American Kennel Club as a purebred Boston Terrier and will provide forms for such registration Unless other wise stated. The breeder reserves the right to affix a kennel name "Kennel Prefix" and supply a registry name for the dog. Affixed Kennel name will be Farm Pasture Boston Terriers or FPB. Buyer will supply the rest of the puppies registered name.

**TYPE OF REGISTRATION:** American Kennel Club AKC. This puppy will only be registered with AKC - American Kennel Club, buyer can not register this puppy with any other clubs.

**Deposit: \$150.00 Non Refundable Unless I Decline You. Deposit & Contract must be sent over night express mail that requires my signature. No personal checks allowed.** We ask that you send a United States postal money order or walmart money order.

If a deposit is being taken before a breeding and the bitch fails to conceive or conveys and losses the litter then you will have to wait until next litter is available. There will be **no cash refunds!**

**All shipping cost and your chosen puppy must be paid in-full before the puppy is 7 weeks of age.**

Please keep in mind that I the Breeder has the right to refuse a sale or cancel a sale at any time. If I the Breeder declines you a sale of a puppy then I the Breeder will return your \$150.00 deposit and any other funds that were received by me within 60 days from the decline. If you the Buyer should decide for whatever reason that you do not want this puppy then the deposit and any funds already received by me will **not be re-funded**. All puppies purchased before 8 weeks of age must be picked up or shipped out by 8 weeks of age. If the puppy in question can not be picked up by 8 weeks of age then there will be a **\$20.00 charge per week** to care for your puppy which must be paid at the time of pick up or before shipping. This fee will cover any additional food, shots, worming and or vet appointments he/she may need. Breeder will only hold the puppy until 10 weeks of age, if the puppy is not picked up or shipped out by 10 weeks of age then Buyer forfeits all money paid on the puppy in question and the puppy will go back up for re-sell, unless prior arrangements are made with me the breeder via e-mail. Any puppy purchased after 8 weeks of age must be paid in-full within 2 weeks of purchase, all care and holding fees still apply.

I the Breeder GUARANTEES the health of this puppy at the time of sale and shipment. If something should happen to this puppy while still in the Breeders care then a replacement puppy of the same sex, color and price as described above will be offered if one is available. If there is no available puppy, then the Buyer may choose to wait for the next litter and have their choice of puppy. If the price of the new puppy is higher than the price listed in this contract the deference must be paid when the new puppy is chosen. If Buyer chooses to decline or refuse this offer then there will be No refund.

Buyer must take this puppy to a veterinarian with in 48 hours of receiving for a get-acquainted visit and check-up. The results of this checkup must be received by me the Breeder within (7 days) from the date of the Exam. Documents must be sent via certified United States postal mail and must require my signature for proof that it was received. If I the Breeder do not receive veterinarian documented proof of this exam within the time mentioned above, then the health guarantee (only) will become null and voided.

Breeder does **not** guarantee against hypoglycemia or any other common problems such as diarrhea, wormy stool, coccidia or coccidiosis, ear mites, internal and external parasites including mange, fleas and or ticks, acne, stress due to shipping or new home. Other minor problems are not covered under this guarantee and are the responsibility of the Buyer. Puppies are susceptible to pneumonia and other infections due to drafts, cold temperature and stress from shipping etc. They are vulnerable to viral infections including Parvo and Corona virus. Any and all of the above mentioned Minor or Major problems need to be checked by a Veterinarian and advise for treatment followed.

This puppy will be up to date on all age appropriate shots and worming before leaving to its new home. It is the Buyers responsibility to complete the puppy vaccination series, provide annual medical examinations and routine health care including vaccinations, worming, heart worm preventative, vet bills etc, once the puppy is in your care. Breeder is not responsible for any accidents or bone growth problems due to poor or improper nutrition that may occur after this puppy has left the care of the Breeder. Failure to follow this will be in breach of contract.

**Puppy Guarantee:** This puppy is GUARANTEED to be free of all **life threatening** congenital defects for a period of 12 months from its date of birth. If this puppy becomes Ill with a **life threatening** congenital defect “meaning it will die” within the first 12 months of its date of birth then your puppy will be replaced with a puppy of the same sex, color and price with-in one year provided that I have received proof from a licensed vet of the diagnosis. If the buyer chooses to receive a puppy of a higher quality and or price, the price of the current puppy covered by this guarantee will apply toward the higher price of the new puppy with the remaining balance owed. Buyer must however pay the shipping fee for the replacement puppy. If Buyer chooses NOT to except another puppy then no refund will be given. I the Breeder will also request any and all information on treatments that are/were available, all veterinarian reports, findings and X-rays. There are many factors that can influence growth and development, such as diet, exercise, weight gain, etc. The buyer assumes the responsibility for the care and feeding of this puppy. This guarantee is non-transferable to future owners of the dog. Buyer will provide me the Breeder with all that is stated here-in before this transaction is set forth.

Breeder highly recommends that you the buyer continue to feed the food that this puppy was weaned onto which is Iams Small Breed Puppy. You the Buyer agrees to give proper care emotionally, physically and nutritionally which also includes following important advice from the breeder when needed. Buyer also agrees not to feed this puppy any supplements, calcium or vitamins unless specified by me the Breeder, it is the Buyers responsibility to maintain this.

Buyer agrees that this puppy is not being purchased for resale nor will it be used or trained for activities which are illegal. It will not be used as a guard or attack dog or to hunt or fight other animals.

Buyer agrees to send up-dates and photos of said puppy at least every 6 months for its life time starting the day they leave our care. We love to watch our babies grow.

In the event that the Buyer is unable to keep the puppy or provide an appropriate home in accordance with this agreement, the puppy **will be returned** to the Breeder **free of charge**. Buyer agrees to notify me the Breeder if any such contingency arises. This puppy is not to be resold or given to another party without written permission from me the Breeder. If I the Breeder choose not to accept the puppy back then I the Breeder will review all of your chosen families and help you chose the right family to place this animal with. All papers pertaining to this animal including medical records, AKC registration and pedigree along with any medication (Heart worm prevention, flea topicals etc) must be turned over to the new owner in the event that this puppy is given back or resold with the Breeders permission.

UNDER NO CIRCUMSTANCES is this puppy to be surrendered to an animal shelter, rescue organization or pet care facility of any kind. I the Breeder will always be available as a safety net for the life time of every puppy we sell no matter what the circumstances are or how old the puppy may be.

If this contract is broke in any way, we will seek legal action along with the return of the puppy that is listed with-in this contract. All legal matters will be handled with-in the state (Texas) and county (San Jacinto) that I the Breeder reside in.

This document constitutes the entire agreement between the breeder and buyer with respect to this sale.
